

Thank you for choosing an Aaron Ranch stallion for the 2026 breeding season.

To help eliminate confusion, please remember the following: FROZEN OR ON-SITE

BREEDING ONLY

Contract:

1. The completed and executed breeding contract is to be returned to the Aaron Ranch along with the required non-refundable booking fee, \$850.00 US funds.
2. The contract is not salable or transferable. **The contract owner is required to be the owner or lessee of the breeding mare; in the case of lessee, a recognized AQHA lease must be provided.**
 - A. Only a "paid in full" breeding contract will be considered for approval, by the Aaron Ranch, for selling. Aaron Ranch will no longer allow a booked breeding to sell with the booked mare.
 - B. Rebreds will be allowed to sell along with the originally bred mare.

Fees:

1. Stallion Fee - \$3500.00 US funds.

Upon presenting the contract for approval, the contract holder may:

- A. Pay the entire stallion fee of \$4350.00, payable in US funds, to the Aaron Ranch, **or**
- B. Pay the booking fee of \$850.00, payable in US funds, to the Aaron Ranch, with the remaining unpaid stallion fee of \$3500 paid when mare checks in foal. (1st Shipment includes 2 doses of frozen semen)(Any additional shipments will be 1 breeding dose per mare for \$850)

2. Frozen semen fee – Paid to Aaron Ranch when semen is requested:

- A. \$0.00 US funds for first shipment
- B. \$850.00 US funds for each additional shipment (1 Frozen Breeding Dose) via Fedex.

3. It is the responsibility of your veterinarian or agent to order semen.

Collection Days: Monday, Wednesday, Friday

4. Aaron Ranch will no longer bill for additional shipments or shipping charges. We are now accepting credit cards or payments through QuickBooks.

5. I hereby authorize Aaron Ranch to charge my credit card the amount listed above plus a 3.5% Convenience Fee.

2026 Frozen SEMEN BREEDING CONTRACT

This agreement between Aaron Ranch (stallion owner), and the owner of the mare described below is dated as of _____, at Commerce, Texas. The mare owner hereby agrees to present the mare _____,

Reg # _____, for breeding to the Stallion **Blind Sided**, during the breeding season.

The breeding season begins February 16 and ends July 3rd. This agreement is subject to the following terms and conditions:

1. The Stallion service fee is \$3500. There is a \$850 non-refundable booking fee. The booking fee is to be returned with this contract

and a copy of the mares registration papers.

The completed contract, along with a copy of the mares registration papers and all booking/shipping fees must be received before any semen will be shipped. All fees should be made payable to Aaron Ranch.

2. The shipped semen fee includes the first semen collection and prepaid federal express delivery. All subsequent shipments, if necessary, must be paid in advance by the mare owner at \$850 per shipment.

The \$3,500 stallion fee must be paid when mare is checked in foal.

3. Under this contract a live foal is guaranteed. It is agreed that a "live foal" is defined as one that will stand and nurse without assistance after foaling. If the foal is born dead or the mare is found to be not in foal, it is the mare owners responsibility to notify Aaron Ranch within seven (7) days. A statement from a licensed veterinarian must accompany this notice. In such case, return privileges will be available the following year only. If the mare is to be returned, another shipped semen fee of \$850 will be due prior to the mare being re bred the following year. The breeding fee will not be refunded.

4. If the mare fails to return for the re-breeding the following year then all fees paid shall be forfeited, the right to a re-breed is canceled, and the stallion owner is released from all further obligation of this contract.

5. If the mare dies or becomes unfit to breed, the owner may return during this season, or the following season only, with a substitute mare approved by the stallion owner, first mare substitute \$0.00, additional mare substitute will be \$250 each.

6. It is further understood that should the above named stallion die, or become unfit for service for any reason, then this contract will become null and void and both parties are relieved of any further obligation hereunder. Any moneys paid by the mare owner toward the stallion fee, with the exception of the non-refundable booking fee, shall be refunded to the mare owner, if the mare has not been impregnated.

7. It is the responsibility of the mare owner and his/her veterinarian to confirm our shipping days. Resident mares have first priority and semen will be shipped on its availability, in the order we are notified. There is no guarantee of availability of cooled semen. Aaron Ranch has the right to refuse shipment when additional shipment is ordered for the same mare during the same cycle.

8. The stallion owner, at his discretion, may ship frozen semen if appropriate based on the stallions schedule.

9. Aaron Ranch only assumes responsibility to ship semen in viable condition, and shall not be held liable for contamination of semen during or after shipment, loss of viability, or any costs arising from shipments delayed, damaged, or lost in transit. Aaron Ranch does not guarantee the fertility of the stallion, but agrees to process each ejaculation to optimize 24-hour post cool motility, and subsequent fertility. Every effort should be made to inseminate the mare within 24 hours after collection from the stallion. Owner agrees to use all cooled semen provided by this agreement for the mare named in this agreement and no other. There is a \$1500 fine for switching mares without prior approval by Aaron Ranch management.

10. A "breeders certificate" will be issued upon notification of the birth of the foal, only if all fees are paid, including any past due bills on any horses owned by the mare owner.

11. NO INTERNATIONAL SHIPPING. United States Only.

United States. (Mare owner is responsible to pay any/all for returning the frozen semen container to the shipper. Any unused frozen semen belongs to Aaron Ranch and is

to be returned when mare is checked in foal at sixty 60 days and/or no later than 9/11/26.

12. The shipping container, with all its contents, must be returned to Aaron Ranch within five (5) business days after the date of delivery. If not returned within 5 days mare owner will be charged up to \$1,600.00 for the cost of the container.
